1	1- Highway 126	Along highway 126.	Fire gets established on South side of highway 126.	USFS Timber Sales, Private Industrial Timber lands, Private residences, and Ranger Station	Notifications: IC notifies AAs, Lane County Sheriff, ODOT, and ensure private landowners have been informed of current condition. Recommended Management Action: Consider new planning area. Initiate discussions with County Sheriffs on potential evacuation plans and planning levels. Mitigation Actions: Consider highway 126 closure, assess holding features along FS roads on the south side of highway 126.
2	2-Comm/Eastern	Ridgetop to east of FS road 1506	Fire gets established across MAP.	Communication site at Frissell, private cabins on FS land, Belnap Hot Springs, river corridor, public safety, wild and scenic values, and other private lands.	Notifications: ICs will notify AAs, Lane County Sheriff's Office, Linn County Sheriff's Office, EWFB, and special use coordinator (ensure LORFs in contact with Belnap Hot Springs) Recommended Management Action: Assess use and ability to implement identified contingency line, point protection for values at risk as needed. Mitigation Actions: Structure wrap for communication site, recommend larger Forest closure, initiate discussions with County Sheriffs about potential evacuation levels.
3	3- Carpenter	North of FS road 1506 (Lookout Creek Rd).	Fire has crossed or is projected to get established north of FS road 1506 (Lookout Creek).	Carpenter Mountain Lookout and HJ Andrews Forest.	Notifications: ICs will notify AAs and Linn County Sheriff's Office. Recommended Management Action: (REFER back to MAP 2 actions) Reassess alternate holding locations north of Lookout Road. Initiate conversations about possible evacuation levels in Linn County. Mitigation Actions: Structure wrap for Carpenter Mountain lookout and initiate discussion of potential larger forest closure.
4	4- HJA	North-South line approximately 1.5 west of Mack creek/Lookout creek confluence.	Fire has crossed or is projected to get established across MAP line.	HJA headquarters and AL&L campground and infrastructure.	Notifications: ICs will notify AAs and Lane County Sheriff's Office. Recommended Management Action: Assess and implement primary and mitigation actions. Mitigation Actions: Assess need for implementing HJA structure protection plan.
5	5- Reservoir	From Junction FS 1509 and FS road 15 south to highway 126.	Fire has crossed or is projected to get established west of Blue River Reservoir.	Communities of Blue River, hydro infrastructure, and private timber lands.	Notifications: ICs will notify AAs, Lane County Sheriff's Office, ODOT, ensure private landowners have been informed of current condition, and Army Corp of Engineers. Recommended Management Action: Reassess planning area, containment lines, and complexity analysis. Mitigation Actions: Initiate discussions with County Sheriff about possible change in evacuation levels. Assess implementation of structure plan for community of Blue River.
6	6- District Boundary	West to East near the Sweet Home and McKenzie district boundaries located along Twin Buttes and Wildcat Mountain.	If fire crosses and gets established or has a high probability of becoming established on north side of the MAP.	Highway 20 corridor, private lands, identified values of McKenzie district.	Notifications: IC will notify AAs, and Linn County Sheriff's Office. Recommended Management Action: Consider new planning area and possible need of a larger closure area. Initiate discussions with County Sheriffs on potential evacuation plans and planning levels. Ensure coordination with Sweet Home District on area closures and identified district values at risk. Mitigation Actions: Consider highway 20 closure, assess holding features along FS roads on the south side of highway 20.
7	7- Hydro/Clear Laker	Approximately from the Deer Creek and McKenzie River confluence to below FS road 410 and current planning area. Stays west of Trail Bridge reservoir, highway 126, and Carmen-Smith Hydroelectric infrastructure.	Fire has crossed or is projected to get established east of MAP.	Carmen-Smith Hydroelectric infrastructure, Clear Lake Resort, Trail Bridge reservoir infrastructure, Smith Reservoir, highway 126 corridor, and various recreational trailheads.	Notifications: IC notifies AAs, Linn County Sheriff, ODOT, and ensure private landowners have been informed of current fire condition. Recommended Management Action: Consider new planning area and updated area closures as needed. Initiate discussions with County Sheriffs on potential evacuation plans and planning levels. Mitigation Actions: Initiate discussions about possible need for highway 126 closure, assess holding abilities of FS roads 655 or other holding locations on the east and west side of highway 126.
