MAP	Description
1	If fire becomes established North of MAP 1 or predicted fire weather or fire behavior indicates the potential to breach MAP 1. Contact LCSO and consider evacuation of Zone 1.
2	If fire becomes established North of MAP 2 or predicted fire weather or fire behavior indicates the potential to breach MAP 2. Contact LCSO and consider evacuation of Zone 2.
3	If fire becomes established West of MAP 3 or predicted fire weather or fire behavior indicates the potential to breach MAP 3. Contact LCSO and consider the evacuation of Zones 3 and 4.
7	If fire becomes established West of MAP 7 or predicted fire weather or fire behavior indicates the potential to breach MAP 7. Contact JCSO & evaluate the evacuation status in Jackson Co. and Gould.
8	If fire becomes established and is moving North of MAP 8 or weather and/or fire behavior indicate the fire moving north from the 14 Road toward the communities to the North. Contact LCSO and evaluate the need to evacuate Zone 8.
13	If fire becomes established East of MAP 13 or weather and/or fire behavior indicate the potential to breach MAP 13. Contact LCSO and evaluate the need to change the evacuation status of Zone 13.
14	If fire becomes established East of MAP 14 or weather and/or fire behavior indicate the potential to breach MAP 14. Contact LCSO and evaluate the need to change the evacuation status of Zone 14.
15	If fire becomes established Southwest of MAP 15 or weather and/or fire behavior indicate the potential to breach MAP 15. Contact RMNP DO on protection measures in the park.
16	If fire becomes established South of MAP 16 or weather &/or fire behavior indicate the potential to breach MAP 16. Consider closing Trail Ridge Rd.
17	If fire becomes established South of MAP 17 or weather &/or fire behavior indicate the potential to breach MAP 17. Contact ROMO DO, LCSO, Estes Park PD & FD. Consider evac of Fall River and Zones 17 and 20.
19	If fire becomes established South of MAP 19 or weather and/or fire behavior indicate the potential to breach MAP 19. Contact LCSO and evaluate a mandatory evacuation within zone 18 & 19 and the south end of zone 10, starting with Storm Mountain.
21	If fire becomes established East of MAP 21 or weather &/or fire behavior indicate the potential to breach MAP 21. Contact LCSO. Consider evacuation of Zones 3, 4, and surrounding areas.
22	If fire becomes established East of MAP 22 or weather &/or fire behavior indicate the potential to breach MAP 22. Contact LCSO. Consider evacuation of Pingree Park, Buckhorn, Box Prairie, and surrounding areas to southeast of fire.
23	If fire becomes established East of MAP 23 or weather &/or fire behavior indicate the potential to breach MAP 23. Contact LCSO. Consider evacuation of Stove Prairie Road and surrounding areas to southeast of fire.
