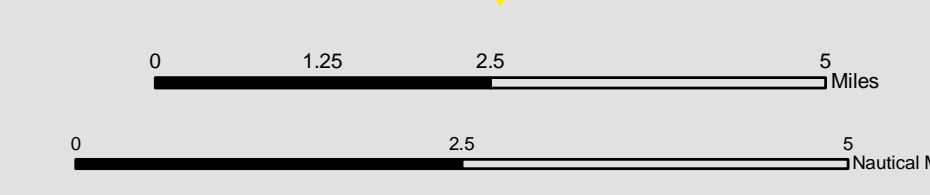


# Apalachicola National Forest All Hazard Response
