

<u>WEATHER DISCUSSION</u>: Strong high pressure ridging has built in over the area and this will continue into Tuesday. The hot dry weather will continue through Monday with a slight increase in moisture over the fire on Tuesday. Even with the increase in moisture expect only isolated thunderstorm development along the sea breeze on Tuesday. A more significant increase in moisture will occur on Wednesday into Thursday with scattered afternoon thunderstorm development.

WEATHER: Partly Cloudy.

**MAX TEMPERATURES:** 93-96 (24 hour trend: Up 1 to 2)

### **Major Hazards and Risks**:

Wear your seat belt every time you get in the vehicle. Obey ALL local laws when driving and remember, the faster you slow it down, the safer you will be! Leave others room between vehicles when parking and find a safe place to park instead of squeezing in.

Weather is getting **HOTTER and DRIER** again! Expect more activity over the next two days. <u>Keep</u> <u>drinking plenty of water</u> throughout the day to prevent heat exhaustion.

**Look Up, Down and Around** for snags, reburns, stump holes, hot pockets and other hazards. Be sure to **communicate** these hazards with all. Mitigate the ones you can and report the ones you can't to your Safety Officer.

If it lives here, it Bites! Snakes, ticks, alligators, bears, sand gnats and other critters are on the move so watch where you walk and check yourself for ticks daily. Do Not play with the wildlife!

**Be aware** of heavy traffic use by log trucks on both dirt & paved roads. Trucks require **higher** speeds on the sandier dirt roads to get through some spots and the best solution is to pull over & allow them to pass.

Lookout(s) Experienced / Competent / Trusted Enough lookouts at good vantage points Knowledge of crew locations Knowledge of escape and safety locations Knowledge of trigger points Map / Weather Kit / Watch / IAP Communication(s) Radio frequencies confirmed Backup procedures and check-in times established Provide updates on any situation change Sound alarm early, not late Escape Route(s) More than one escape route Avoid steep uphill escape routes Scouted: Loose soils / Rocks / Vegetation Timed: Slowest person / Fatigue & Temperature factors Marked: Flagged for day or night Evaluate: Escape time vs. Rate of spread Vehicles parked for escape Safety Zone(s) Survivable without a fire shelter Back into clean burn Natural Features: Rock Areas / Water / Meadows Constructed Sites: Clearcuts / Roads / Helispots Scouted for size and hazards Upslope? ~ Downwind? -More heat impact  $\rightarrow$  Larger safety zone Heavy Fuels?

Escape time and safety zone size requirements will change as fire behavior changes.

- 2. The Section Chief agrees and notifies the Demob Unit Leader.
- 3. The Demob Unit Leader has a 24+ hour window to reassign you to another incident or arrange for transportation to your home unit.

## B. WHAT CAN YOU DO TO EXPEDITE THE PROCESS?

- 1. Turn in all time report and equipment use records to Time.
- 2. If you have equipment, have an inspection completed by **Ground Support.**
- 3. Turn in any non-essential items you have checked out to <u>Supply</u> or <u>Communications.</u>
- 4. Complete and turn in Unit Logs on a daily basis to
   <u>Documentation</u> and get a Performance Evaluation from your supervisor (you keep original and a copy goes to the files)
- 5. If there is any change in your status, notify **<u>Demob</u>** immediately.
- 6. Check the Demob Board on a regular basis. Be available to move within a 1 to 2 hour notice.
