3. Objective(s): 1. All operations will be conducted with safety of the public and firefighters in mind. Protection of life and property is your highest priority task. When in doubt, sacrifice acres rather than firefighter and public safety. 2. Provide timely and accurate information regarding the incident's status and strategy to cooperating agencies, stakeholders, property owners, public, and media. Coordinate information sharing with LDAF and the State Fire Marshall's Office. 3. Manage the human resources assigned to the fire incident in a manner that promotes mutual respect and is consistent with interagency human resources objectives. The team will handle EEO complaints in consultation with LDAF Human Resources involving personnel attached to the team. 4. Continue partnership and coordination with the appropriate LDAF, State Fire Marshall, GOHSEP, and local public safety officials. 5. Manage the incident in a cost effective manner.																
4. Operational Period Command Emphasis: Stop, Think, Discuss, then Act and ensure LCES is in place prior to engaging the fires. Ensure that the Tiger Island, Highway 113, Lions Camp Road, and Elizabeth Fires receive a strategic, risk-based response commensurate with the threats and opportunities and uses the full spectrum of management actions that consider fire and fuel conditions, weather, values at risk, and resources available.																
General Situational Awareness Watch Out Situations: Extreme heat, dry fuels, and fire behavior. Aviation use and possible long medevac times. Cumulative fatigue. Maintain situational awareness - your division, the divisions working near you, and your chain of command.

FIRE BEHAVIOR:

With critically dry fuels, temperatures in the mid 90's and RH in the mid 40's expect moderate to high fire behavior. Fuels are critically dry. **KBDI (779), 100hr FM 10, BI of 20 remains at critical levels above the thresholds for increased fire activity and growth.** Fuel conditions combined with winds, especially during the afternoon, have the potential to produce very active fire behavior. Live fuel moistures are critically low (45-55%) and should be treated as fully cured/dead.

In **15 minutes**, a new spot fire or ignition during peak burn conditions in receptive fuels that could reach **3 acres.**

Specific Areas of Concern:

All Divisions: Heavy fuels in drainages, logs and dozer berms will continue to hold heat and provide the ignition source for reburn during the peak burning period. It is very important to keep the needle/cast cleared from all holding lines. Conditions will be favorable for new ignitions.

Tiger Island: Critical to check heat identified on the IR and reburn areas. Monitor the unburned fuels in the drainages and timber stringers. Fuel and weather conditions will support the potential for reburn in the brush and needle/leaf cast during the peak burning period. The spot in DIV A is an area that needs attention.

Hwy 113/ Elizabeth: Critical to check heat identified on the IR and reburn areas. Monitor the unburned fuels in drainages, timber stringers. Heavy fuel loads in the drainages continue to dry out and the potential for reburn increases along 10-mile creek in both fires.

Lions Camp Road: Monitor fires for hot spots and reburn, especially during mid-afternoon during the peak burn period.

Air Operations:

Generally good conditions. Isolated storms in the afternoon may affect air operations.

Fire Behavior Safety Message:

Keep a close watch for thunderstorms. Strong outflow winds rapidly change spread direction and create additional hazards with falling snags.

Major Hazards and Risks: Transition (Shadow) Day, Heat Related Illness

Transition: Today the transition of teams will be taking place with the Gold Team shadowing the Blue Team. There will be a lot of new faces on all fires and around ICP. Communication is essential to ensure the exchange of information happens. Clear communication means both parties understand the information. That is why we repeat back what we are told – to ensure the information is understood. Ask questions if there is any doubt. It is better to over communicate vs. not being sure someone has the information they need. The incident objectives have not changed, so the work needed to help the State of Louisiana continue to keep the fires contained within the current control lines remains a main objective.

Heat Related Illness: Pace of work directly affects your risk of heat related illness. Hydrate early and often to avoid getting into a deficit. Take frequent breaks in the shade and if someone acts strangely it is time to get them cooled down.

Symptoms of Heat Related Injury

- Profuse sweating leading to hot dry skin
- Transient muscle cramps
- Feeling weak
- Dizziness, headache, and irritability
- Rapid, weak pulse
- Vomiting
- Confusion or change in typical behavior
- Loss of consciousness

IWI IC Responsibilities – Division Group Supervisor or Point of Contact

- Take charge of the scene – inform the Division Supervisor and Tiger Island Communications that you are the IWI IC and establish radio communications (frequencies, channels). Identify the emergency name – Division A medical, etc.
- **For backup IWI communication, call the communications phone: (804) 807-5821.**
- Assign or begin patient assessment (Medical Incident Report - MIR) and first aid. Request additional medical resources on division/branch or across incident. Transmit MIR patient information to Communications.
- Determine patient transportation through consultation with line medical personnel and Medical Unit Leader. Consider transportation time, risk to personnel, destination facility and available operational resources. If air transport is chosen, implement the plan for alternative transportation in the event aircraft cannot complete the mission. Order transportation resources through Communications as early as possible.
- Notify Communications as resources arrive and any patient status changes. Names of injured or deceased individuals will not be transmitted on the radio.
- Initiate documentation for future investigation; if a line safety officer is available, assign them to lead documentation. Do not move deceased individuals, gear or personal effects except to accomplish rescue work or protect the safety of others. Obtain written documentation of witnesses. Unit Log, ICS 214, may be used for initial documentation, but a narrative will be required.
- As appropriate, conduct an After Action Review to determine successes, areas to improve and lessons learned.

Medical Incident Report

FOR A NON-EMERGENCY INCIDENT, WORK THROUGH CHAIN OF COMMAND TO REPORT AND TRANSPORT INJURED PERSONNEL AS NECESSARY.

FOR A MEDICAL EMERGENCY: IDENTIFY ON SCENE INCIDENT COMMANDER BY NAME AND POSITION AND ANNOUNCE "MEDICAL EMERGENCY" TO INITIATE RESPONSE FROM IMT COMMUNICATIONS/DISPATCH.

Use the following items to communicate situation to communications/dispatch.

1. CONTACT COMMUNICATIONS / DISPATCH (Verify correct frequency prior to starting report)

Ex: "Communications, Div. Alpha. Stand-by for Emergency Traffic."

2. INCIDENT STATUS: Provide incident summary (including number of patients) and command structure.

Ex: "Communications, I have a Red priority patient, unconscious, struck by a falling tree. Requesting air ambulance to Forest Road 1 at (Lat./Long.) This will be the Trout Meadow Medical, IC is TFLD Jones. EMT Smith is providing medical care."
