5. GENERAL CONTROL OBJECTIVES FOR THE INCIDENT (INCLUDE ALTERNATIVES)

Control Objectives

- 1. Provide for the safety of firefighters and general public by adherance to the 10 standard fire orders, 18 watch-out situations, in addition to maintaining direct and clear communications with all incident personnel and the general public.
- 2. Keep fire contained west of US Highway 264, south of US Highway 64 and east of Milltail Creek.
- 3. Coordinate with Dare Emergency Mangement Coordinator to initiate evacuation if fire threatens the village of Stumpy Point.
- 4. Continue to monitor traffic conditions on US Hwy 264. Maintain 24 hours LE presence at designated areas to provide for immediate closure, if needed, for escaped fire.
- 5. Make appropriate notifications to NCDOT, EM, NC State Highway Patrol, USFWS and D13 operations for predicted "superfog" or dense smoke events.
- 6. Continue to implement written Water Handling Plan.
- 7. Ensure that suppression & containment strategies on FWS property follow minimum impact suppression tactics. Escalation of tactics should consider amount of progress being made with current tactics, and the likelihood of those tactics being successful.

Management Objectives

- 1. Keep general public & local officals in affected counties, as well as incident stake holders informed of fire status through situation updates and personal contacts.
- 2. Provide for accurate cost tracking and documentation of incident in accordance with IBH (Incident Business Handbook) procedures.
- 3. Emphasize cost containment through continual assessment of personnel and resource needs to provide correct staffing of incident.

Fire Behavior Forecast

Time and Date Forecast Issued: 1900 Saturday 6/4/ 2011

For: Sunday 6/5/2011

Weather Summary: High Pressure moved south and east of the fire area last evening. A cold front and trough of low pressure will move through this afternoon with scattered thunderstorms developing by around noon. Up to ¼ inch of rain may fall with higher amounts in heavier storms. Some severe storms are possible with the main threat being gusty winds. The front will move through by evening with clearing skies.

Today will be Mostly Cloudy with Scattered showers and thunderstorms late in the morning. Gusty winds near thunderstorms.

High temp 86, Minimum RH 57%. Light and variable winds becoming SE 5-7

General Fire Behavior: The fire escaped containment on the southwest side yesterday in Division Alpha and ran north towards the Air Force Bomb Range forcing burnout of an entire 11,000 acre block.

Specific Fire Behavior

Alpha, Delta, Echo, Oscar – Expect active burning in remaining green fuel. SW to SE winds will continue to push the fire through the block and put pressure on Jackson Road. Watch for spotting on the north side of Jackson Road. Charlie, Foxtrot – Remaining ground fire on the spotover along Long Curve Road may become active later today. Mike, November - These divisions contain ground fire in the interior and along the perimeter. There is also active fire creeping in the litter of these divisions with occasional flare-ups that die back down. Green fuels will continue to burn and cured but unburned fine fuels will also reburn causing flare-ups. Lofting embers along perimeters may cause spotting into unburned fuels. Shading of fuels and partial to full sheltering from the wind should contribute to containment efforts. The fire should be active later today with the forecasted weather conditions.

ERC...39 is a number <u>related to the available energy</u> (BTU) per unit area (square foot) within the flaming front at the head of a fire. As live fuels cure and dead fuels dry, the ERC will increase and can be described as a build-up index.

Controllability- Indirect attack should be used if fires become established. Aircraft should always be utilized in the containment effort.

Major Hazards and Risks:

<u>**DRIVING</u>** - Drive defensively. Use passenger as a lookout, navigator, and backing guide. Obey speed limits. Use headlights and seatbelts. 10 MPH in very dusty road conditions. Clean your windows. Watch out for Bears! <u>**FIRING OPERATIONS**</u> – Ensure all resources are briefed prior to starting firing operation. LCES should be in place and reevaluated during operation.</u>

<u>AIR OPERATIONS</u>- Stay away from bucket and retardant drop areas. <u>Use air to ground frequency when</u> <u>communicating with aircraft.</u> Stay safe distance from drop zones of tankers and helicopters.

<u>HYDRATION/HEAT STRESS</u> - Temperatures are on the rise. The body shuts down the thirst mechanism when you're dehydrated, therefore, be sure to drink a lot, before you get thirsty. 4:1 water to Powerade or Gatorade.


<u>FIRE BEHAVIOR</u> – Maintain situational awareness, follow 10 Standard Orders, recognize / mitigate the 18 Watch Out Situations, and apply LCES. Know the fire weather forecast. Monitor conditions.

<u>Pumps</u> - Operators and Mechanics should be the only personnel near pumps. PTOs and exposed drive belts can injure you. Canal banks can collapse. Noise levels can be high. Shut down pumps to service.

<u>ENVIRONMENTAL HAZARDS</u> - Watch for and stay away from rattlesnakes, stinging insects and wildlife. Use appropriate insect repellents. If bitten or stung, seek medical attention immediately.

<u>SNAGS</u> – Stay out of area, essential fireline personnel only. Look at root system before working/parking. Refer to IRPG pg. 20-21.

All radio traffic will be kept to a minimum so emergency procedures can proceed uninhibited. Step 2. ICP Communications will notify Dare Central Dispatch (911) and MEDL. Safety will be notified. Dare County EMS will respond and determine the appropriate treatment, transportation and facility needed. If ground transportation is determined, assign personnel to meet the ambulance at a location that is easily accessible to lead them to the site of the injured. If patient is transported to meet EMS personnel need to remain with patient until EMS has arrived. Line EMT is staged at Navy Shell & Long Curve Rd. to respond to injuries and stabilize patient until EMS personnel arrive. <u>**FOR MINOR EMERGENCIES**</u> Step 1. 


