The fire received rainfall Tuesday and Wednesday evening for a total of approximately .3 inch. The rain will diminish the fire activity for several days as the fuels dry out. Major runs in the bay shrubs and southern rough fuels have been observed. Currently smoldering ground fire has been observed along with active burning in the litter and flare-ups in the shrubs that die back down. The fire has burned actively in green and cured fuels. Torching has been observed with some spotting. Watch for needle/leaf cast on all divisions which will provide surface fuels for smoldering or active ground fire.

Predicted Fire Behavior for Today

Additional measurable rainfall will help to diminish fire activity

Expect continued smoldering in organic soils. Active burning may be observed in the timber litter and southern rough fuels on the sand ridges. Rates of spread and flame lengths are given for flanking fire and head fire in the table below. Spotting distances and probabilities of ignition are also given. Watch for erratic fire behavior near storms with gusty winds.

Major Hazards and Risks:

<u>DRIVING</u> - With roads getting wet be heads up for slick conditions. Practice defensive driving techniques maintain a safe speed on highways around the fire, and traveling back and forth to the motel. Use spotters when backing, and honk horn to alert personnel.


<u>HYDRATION/HEAT STRESS</u> - Temperatures are on the rise. The body shuts down the thirst mechanism when you're dehydrated, therefore, be sure to drink plenty of fluids, before you get thirsty. Take frequent breaks, watch your co-workers for heat related symptoms.

<u>FIRE BEHAVIOR</u> – Maintain situational awareness, Be heads up with thunderstorms and downdrafts in the area adhere to the 30/30 rule.

<u>COMMUNICATIONS</u> – It is critical on any incident that we hold mandatory tailgate safety briefings with all crews before moving to the line. Maintain radio communication between personnel and divisions check radios before work shift or moving to new location. COMMUNICATE ESCAPE ROUTES AND SAFETY ZONES.

<u>ENVIRONMENTAL HAZARDS</u> - Watch for and stay away from rattlesnakes, stinging insects and wildlife. Use appropriate insect repellents. If bitten or stung, seek medical attention immediately. <u>SNAGS</u> – Stay out of area, essential fireline personnel only. Look at root system before working/parking. Refer to IRPG pg. 20-21.

Heat Index!

Heat disorders generally have to do with a reduction or collapse of the body's ability to shed heat by circulatory changes and sweating or a chemical (salt) imbalance caused by too much sweating. When the body heats to quickly to cool itself safely, or when you lose much fluid or salt through dehydration or sweating, your body temperature rises and heat-related illness may develop. Heat disorders share one common feature: the individual has been in the heat too long is exercised too much for his or her age and physical condition.

Studies indicate that, other things being equal, the severity of heat disorders tend to increase with age. Conditions that cause heat cramps in a 17-year-old may result in heat exhaustion in someone 40, and heat stroke in a person over 60
