<b><u>OBJECTIVES:</u></b>			
<ol style="list-style-type: none"> <li>1. Firefighter and public safety will be enhanced through the use of sound risk management and hazard mitigation. Stop, Think, Talk and then Act. Establish a shared commitment by all, that operations are implemented with the least firefighter exposure necessary to meet incident objectives.</li> <li>2. Keep fire North of the I-40, South of Hurricane Spur, West of Hurricane Creek Road and East of Cold Springs Road.</li> <li>3. Use suppression strategy and tactics commensurate with resource values. Protect the purchased commercial timber stands in the Twelve Mile area, the Bear Sale and Raven Sale, by not allowing fire to enter the stands or minimizing the fire impacts, to avoid financial loss and the ecological benefits from the planned timber harvesting.</li> <li>4. Minimize fire impacts to protect private property and private and public infrastructure along Hurricane Creek Road (also know as Haynes Road), particularly structures and the cemetery, and the Harmon Den Campground and Day Use Trailhead, to reduce the potential for adverse social, financial, and economic hardship.</li> <li>5. Use and enhance the strong relationships with local and state cooperators, and communities to collectively meet the objectives of the incident and to build capacity for future events.</li> <li>6. Ensure timely and accurate information is distributed to interested parties, partners, timber sale purchasers, adjacent private landowners, affected outfitters and permittees, and local and state government through good communication with Agency Administrators and by implementing an effective public information effort.</li> <li>7. Manage the incident in the most efficient and cost effective manner that is commensurate with values at risk.</li> </ol>

<ul style="list-style-type: none"> <li>• Recon. Get familiar with the local area and fire area. Get to know local resources. Gather intel to be used in mid-range planning efforts. Ask yourself, "Is this action necessary? Evaluate all tactics with safety in mind.</li> </ul>

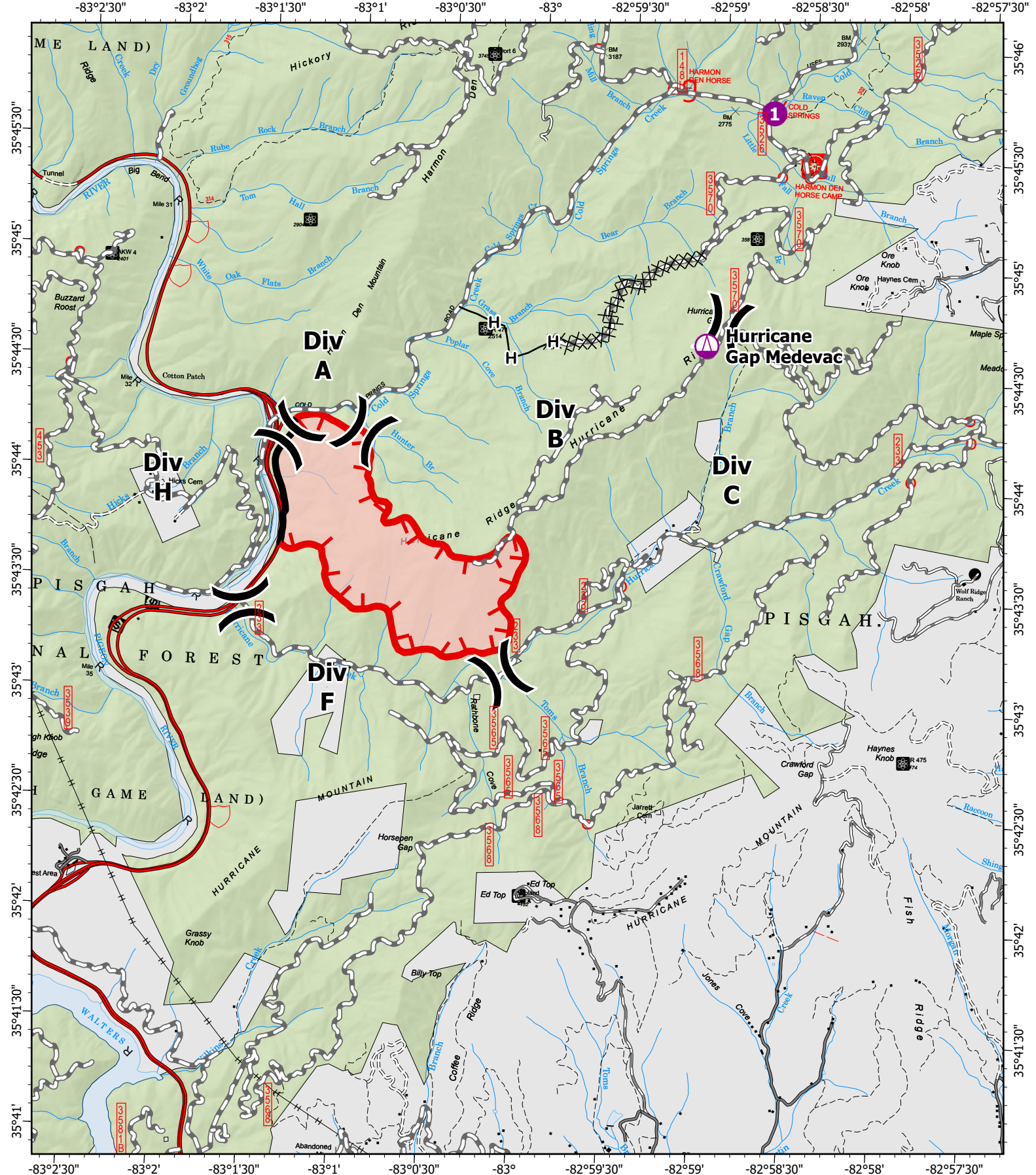

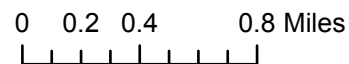

**1. CONTACT COMMUNICATIONS / DISPATCH (Verify correct frequency prior to starting report)**

**2. INCIDENT STATUS: Provide incident summary (including number of patients) and command structure.**

*Ex: "Communications, I have a Red priority patient, unconscious, struck by a falling tree. Requesting air ambulance to Forest Road 1 at (Lat./Long.) This will be the Trout Meadow Medical, IC is TFLD Jones. EMT Smith is providing medical care."*
