



**MAP 4:** Fire becomes established north of County Line / Riverdale Road, west of county line.

- Notify Jones County Emergency Management.
- Take aggressive suppression tactics to minimize fire spread and consider the use of aircraft the use of additional dozers.
- Notify large land owning interests.

Resource Need: 1 TFLD, 1 Strike team of Tractor plows, 1 T6 engine, 1 T3 Helicopter

**MAP 1:** Fire becomes established north of County Line/ Riverdale Road east of county line.

- Notify Craven County Emergency Management of the threatening fire and activate evacuations in the affected areas.
- Take aggressive suppression tactics to minimize fire spread, consider the use of aircraft the use of additional dozers.
- Notify large land owning interests.

Resource Need: 1 TFLD, 1 Strike team of Tractor plows, 1 T6 engine, 1 T3 Helicopter

**MAP 3:** Fire becomes established east of identified management action point that runs southeast from County Line/Riverdale Road to Catfish Lake Road.

- Notify Craven County Emergency Management.
- Notify DOT of the threat to HWY 70 and consider law enforcement for potential road closures and smoke impacts.
- Take aggressive suppression tactics to minimize fire spread and consider the use of aircraft the use of additional dozers.
- Notify large land owning interests.

Resource Need: 1 TFLD, 1 Strike team of Tractor plows, 1 T6 engine, 1 T3 Helicopter

**MAP 2:** Fire becomes established west of improved dozer line and/or Mattocks Road.

- Notify Jones County Emergency Management.
- Take aggressive suppression tactics to minimize fire spread and consider the use of aircraft the use of additional dozers.
- Notify large land owning interests.

Resource Need: 1 TFLD, 1 Strike team of Tractor plows, 1 T6 engine, 1 T3 Helicopter

**MAP 5:** Fire directly impacting Woodcock Timber Sale (in Hollingsworth & Holston Creek Road)

- Notify Forest Service Timber Sale Administrator.
- Take aggressive suppression tactics to minimize fire spread and consider the use of aircraft the use of additional dozers while considering mechanical damage to timber resources.

Resource Need: 1 TFLD, 1 Strike team of Tractor plows, 1 T6 engine, 1 T3 Helicopter

**MAP 8:** Fire established south of Holston-Hunter Road

- Notify Jones County Emergency Management
- Take aggressive suppression tactics to minimize fire spread and consider the use of aircraft the use of additional dozers.
- Notify large land owning interests.

Resource Need: 1 TFLD, 1 Strike team of Tractor plows, 1 T6 engine, 1 T3 Helicopter

**MAP 6:** Fire established in Pond Pine Wilderness

- Implement pre-approved wilderness suppression actions and consider requesting those tactics not already pre-approved.
- Take aggressive suppression tactics to minimize fire spread and consider the use of aircraft and or additional resources allowed within Wilderness Management Plan/Forest Plan.

Resource Need: 1 TFLD, 1 Strike team of Tractor plows, 1 T6 engine, 1 T3 Helicopter

**MAP 7:** Fire established and threatening Camp Bryan and / or Pine Grove/Cherry Point Community.

- Notify Craven County Emergency Management.
- Notify US Marine Corps Air Station, Cherry Point.
- Take aggressive suppression tactics to minimize fire spread and consider the use of aircraft the use of additional dozers.
- Notify large land owning interests.

Resource Need: 1 TFLD, 1 Strike team of Tractor plows, 1 T6 engine, 1 T3 Helicopter
