The Southern Area IMT in cooperation with Texas Forest Service, FEMA, and the Texas National Guard continues to manage and support the functions of the Beaumont RSA and PODs in Southeast Texas. The Southern Area IMT, State, County, Military and FEMA representatives and resources are working closely in a coordinated effort to establish efficient support to

PODs and first responders. The Southern Area IMT is providing logistical support for the Beaumont RSA which is currently staging EMS Services, military personnel and several other first responders and law enforcement officials from the State of Texas. The Beaumont RSA is currently supporting 19 POD locations in Jefferson, Liberty, Chambers, Orange and Hardin Counties in Southeast Texas. For the current reporting period the Beaumont RSA has received 4 trailers of MREs and 1 trailer of ice. Commodities processed out to various PODs during the current reporting period consist of 1 trailer of MREs, 1 trailer of ice, 5 trailers of water, and 1 trailer of miscellaneous support items. Since the Southern Area IMT assumed command of the Beaumont RSA, cumulative totals of commodities processed to PODs consist of the following approximate numbers of trailers: Blankets 1, Cots 6, MREs 19, Ice 40, Water 73 and 47 miscellaneous support items.

The Southern Area IMT will begin transition with the New York State IMT, on 9/10/17 and transfer of command will occur at 1900, on 9/10/17.
