Transportation - Ground	MVA - Pedestrian/Bicyclist	Possible	Critical	High	CDT foot traffic on Highway 96 may be impacted by fire vehicle traffic. Utilize signage to inform road traffic of the presence of pedestrians along the highway.	Unlikely	Critical	Moderate	YES	Liason / SOF
Firing Operations - Aerial	Aircraft Mishap - General	Rare	Catastrophic	Moderate	Appropriate level of risk management for each mission, air attack prioritize missions & de-conflict airspace. Evaluate smoke conditions and transfer of risk daily	Rare	Critical	Moderate	YES	All Air Resources
Indirect Line Construction - Mechanical	Equipment - Crushed by Heavy Equipment/Rollover	Unlikely	Critical	Moderate	Utilize road guards and maintain adequate working distance from heavy equipment to minimize chance of mishap.	Unlikely	Critical	Moderate	YES	All Line Resources
Patrol/Secure Fires Edge/Mop up	Burns /Ash Pits/Stump Holes/ Fire weakened trees	Unlikely	Critical	Moderate	Eliminate the hazards with qualified sawyers, or heavy equipment. Avoid hazards by designating "no work zones". Flag, sign, and map. When utilizing flagging, circle entire area within collapse zone as to be as visible as possible. (IRPG pp. 21) Only mop up and secure fire that is a threat to fire perimeter.	Unlikely	Critical	Moderate	YES	All Operational Personnel
All Incident Operational Tasks	Allergic Reaction - Insects/Animals	Unlikely	Critical	Moderate	Mark all known bee/wasp nests in work areas. Be aware that Poisonous snakes may be present in wild areas.	Unlikely	Moderate	Low	YES	All Incident Personnel
All Incident Operational Tasks	Hostile Wildlife	Unlikely	Critical	Moderate	Potential for dangerous encounters with bears, moose, or mountain lions. Secure all food in and around camps, do not have food in tents. BACK HAUL TRASH DAILY. If encountering wildlife move out of area immediately. Consider ordering bear spray for trained individuals.	Rare	Negligible	Low	YES	All Incident Personnel
